4. Reports

- i. Chair
- BG expressed concerns about the possible pollution issue in the ponds. Severn
 Trent have been seen working there but Sunish does not seem to have any
 information about the works carried out. The worry is that any contaminant may
 have seeped into the beds even if the source of the pollutant has been repaired. Sp
